GET FUNDING TO IMPROVE YOUR WATER EFFICIENCY

We'll evaluate any ideas that save water, but here are some examples of qualifying projects:



Indoor fixture replacements (toilets, urinals, faucets, shower heads)



Air conditioning condensate capture and reuse



More efficient reverse osmosis



Industrial laundry equipment upgrades



Enhanced or added water reclamation systems



Replacement of water-cooled equipment with air-cooled equipment (like ice machines)



Elimination of water intensive industrial processes



Car wash system and equipment upgrades



Boiler and steam system upgrades



Laboratory and equipment upgrades.



Landscape irrigation system upgrades (smart controllers, drip conversions, zone adjustments).



Cooling tower modifications.

WHO QUALIFIES?

Custom incentives are for commercial, industrial, institutional, and multi-family water users registered with the State of Utah and operating in Jordan Valley Water's service area. While funding is typically for retrofits of existing equipment or processes, we will consider projects for new construction if they go above and beyond accepted standards of the given industry.

Note: Leak repair and regular maintenance do not qualify for incentives.



HOW DO I GET STARTED?

HOW MUCH ARE THE INCENTIVES?

Incentives are based on actual water savings of your project and the life of the equipment being replaced. Only technologies and practices that have been independently tested and verified to reduce water use can receive incentive money. To discuss specific projects and rebate amounts, give us a call.
